## TERMS & CONDITIONS

Safe with AltKuz Ltd ('SwA') is a Company House, UK- registered, Limited Liability firm that offers Personalised and Group Safety Solutions in Personal Mobility, Government or Corporate Space Missions, & Public Transportation. Sponsored by AltKuznets Sustainability Advisors Pvt Ltd, Safe with AltKuz Ltd was incorporated in April of 2024 with its Registered Offices in Glasgow, Scotland. It is headed by Prasad Rao, an MTech (IIT KGP), PhD (PennState)-qualified, DIN-issued Director.

This note lays out the more significant Terms & Conditions that govern its engagement with its Precinct Customers & Business Clients.

Our copyrighted Safety paradigm seeks and intends to operate in peaceful times characterized by minimal, if any, anthropogenically-engendered, consciously-strategized and enforced Health or Safety Risks.

On account the primacy of Life and safety, Safe with AltKuz has adopted stringent business diligences. It administers its operations and provides Safety Services thru its Safety Design and IPR Capital free of any and all inane personal statements or actions, or public interruptions in any aspect of its business. It conducts its business through formal, regulator-visible transactions that emphasize authenticity of licenses. Safe with AltKuz Ltd does not permit 'ethereal or what if' administration of its Safety Copyright and Biz Strategy, in whatsoever form, by any entity unless explicitly and formally recognised by the Board of Directors of the firm. Safe with AltKuz Ltd has adopted an [AoA-conformable](#), formal, License-based policy when negotiating Safety Contracts with different Client classes. The firm seeks its business from Government Ministries, Regulatory Institutions, Sovereign Space Authorities, Space Firms,

Transport Authorities, Boards, as well as Corporate Ride Share, Inter-city & Fleet Operators across various modes of transportation. It offers various classes of Safety products that meet the differentiated needs of its clients.

Toward its business operations, Safe with AltKuz Ltd has adopted a policy for :

### **Regulatory Conformance**

Safe with AltKuz Ltd requires broad conformance with the intents of extant Transport regulations and Guidelines for Vehicle/Craft Safety and its Operators & Controllers. All Safety Licenses are issued subject to Precinct regulations. Our Licenses are explicitly issued free of any obligation, charge, or hold from Personal or Group Life/Vehicle/Craft/Launch Insurance Policies in force over the License period. In addition to formal Registration and application for a Licence, Individuals and Firms must submit a refundable Caution Deposit with pre-Licence Registration, and additionally endorse our right to charge their Credit Cards for violation of License terms. Further, Safe with AltKuz Ltd may, due regulatory or other unforeseen reasons not in its control, declare Force Majeur on its Licenses, and require Licensees to abide by its directions.

Safe with AltKuz has preferred to initiate Customer & Client relationship with a free, introductory License 'look-in' period, post which, it'd, upon expression of further interest by Licensee, negotiate Customer/Client-specific contracts & licenses. A '*No Questions asked Money Back*' guarantee covers Licenses issued Individuals. Our Safety assurances are limited to pre-negotiated and formally-issued and authenticated Licenses. Safe with AltKuz Ltd intends to limit its services to its *pre-contracted* 'Safety as a Service', SaaS Licensees. It will not bear any onus for incidents that might occur beyond the narrowly-defined context of its licences. Further, our Licenses and associated Safety services are specific to the period of issue. They turn invalid and void post expiry date.

### **Terms of Business**

Safe with AltKuz Ltd intends to abide by Companies House rules and guidelines, and cooperate with Sector Regulator-indicated Submissions. It'll insist on Client-confidentiality with the signing

of formal contracts & licenses, albeit as limited by Precinct Regulations. Interested Parties may contact us by phone, email, or through the services of Embassy Representative, or Business Managers. They may also seek a confidential meeting through any International Business Bank that has a presence in the vicinity of our Office. Interest parties are urged to verify our credentials, evaluate our capabilities and potential, and engage diligences mutually, and ensure compatibility, prior making a decision to purchase our SaaS Licenses.

### **Employee Relations**
